Minutes of the 133rd meeting of the Board of Approval for SEZs held on 15th October, 2025 at 04:00 p.m.

The One Hundred and thirty three (133rd) meeting of the Board of Approval (BoA) for Special Economic Zones (SEZs) was held on 15th October, 2025, in virtual mode. The list of participants is at **Annexure-I.**

The item-wise decisions taken by the Board are as below:

Agenda Item No. 133.1:

Ratification of the minutes of the 131st meeting of the Board of Approval for Special Economic Zones (SEZs) held on 28th August, 2025.

The Board **ratified** the minutes of the 131st meeting of the BoA for SEZs held on 28th August, 2025.

Agenda Item No. 133.2:

Request for extension of LoA of SEZ Unit [4 proposal - 133.2(i)-133.2(iv)]

133.2(i) Request of M/s. Sandhill Aviation IFSC Private Limited, a unit at Unit No. 624, 2nd Floor, Signature Building, GIFT Multi Services SEZ Gandhinagar for the extension of the Letter of Approval (LOA) for further period of six month i.e. upto 19.03.2026.

The matter was discussed in detail and the Executive Director, IFSCA informed that the firm has already paid advance for the aircraft and is on the verge of commencing commercial operations. Therefore, IFSCA recommended that the extension of validity of LoA for a further period of six months, i.e., upto 19.03.2026, may be considered to support the Unit in starting its operations. IFSCA assured that the following pending compliances shall be strictly enforced/monitored:

- i. Execution of the lease deed for the premises;
- ii. Appointment of a Director/Compliance Officer;
- iii. Payment of applicable late fees and interest on delayed payments to IFSCA:
- iv. Submission of mandatory monthly and half-yearly reports, confirmation; certificates, and audit certificates since the inception of the Unit;
- v. Signing of lease agreement with IFSCA.

The Board, after deliberations and in view of the submissions made by IFSCA, noted that the steps taken by the unit to acquire an aircraft is a positive movement towards commencement of the leasing activity, and **granted** extension of validity of LoA for a further period of six months, i.e., upto 19.03.2026.

The Board directed that failure to meet the above compliances within extended period of six months shall be viewed adversely.

133.2(ii) Request of M/s. Nutana Aviation Capital IFSC Pvt. Ltd, a Unit at Unit No.63 (4 seats), Ground Floor, The Platform, 11T2, Block-11, Processing GIFT SEZ, Gift City, Gandhinagar for the Extension of the Letter of Approval (LOA) for further period of one year i.e. Upto 09.08.2026.

The Board, after deliberations, **granted** extension of validity of LoA for a further period of one year, i.e., upto 09.08.2026, as the written explanation/justification submitted by Unit was considered and recommendations by IFSCA, was found satisfactory.

133.2(iii) Request of M/s. Contrails Aviation IFSC Private Limited, a unit at GIFT SEZ Gandhinagar for the Extension of the Letter of Approval (LOA) for further period from 09.06.2023 to 08.06.2026.

The matter regarding extension of Extension of the Letter of Approval (LOA) originally issued on 09.06.2022, for a period from 09.06.2023 to 08.06.2026 was discussed in detail. During the course of Meeting JS, SEZ apprised the Board that as per Rule 19(4), LoA is valid for one year. The first proviso to the Rule grants power to the DC for extending the LoA for a period not exceeding 2 years, while the second proviso grants further power to DCs for extending the LoA for one more year subject to the condition that two-thirds of activities including construction, relating to the setting up of the Unit is complete and a Chartered Engineer's certificate to this effect is submitted by the entrepreneur. Further, -

- i. Extensions beyond 4th year (or beyond 3rd year in cases where two-third activities are not complete) and onwards can be granted only by BoA.
- ii. BoA can extend the validity for a period of one year at a time.
- iii. There is no time limit up to which the Board can extend the validity.
- iv. In the instant case, two-thirds of activities have not been completed by the unit.

In view of the above rule position, the Board, after deliberations, and on explanation/justification submitted by IFSCA, **granted** the extension of validity of LoA for a further period upto o8.06.2026 (i.e., the 4th year w.e.f. date of LOA), **subject to post-facto regularization of validity** from 09.06.2023 to 09.06.2025, by the concerned DC (Administrator, IFSCA) as per the provisions of Rule 19(4).

133.6(i) Request of Surat SEZ for cancellation of LoA of M/s. C Tech Corporation after lapse of extension of validity granted by BoA after hearing appeal of the unit against the Order-in-Original dated 11.06.2024 passed by DC, Surat SEZ.

DC, Surat SEZ informed the Board that after lapse of extension of validity (upto 04.05.2025) granted by BoA in its 124th meeting held on 05.11.2024, M/s. C Tech Corporation has failed to achieve any of the milestones submitted by them including export orders and the proposed timeline for commencement of manufacturing operations. The unit has neither imported nor procured any raw materials from DTA, has not generated any employment, and has undertaken no manufacturing activity during the extension period granted by the Board of Approval (BoA). The unit was non-functional since April, 2017 with no valid justification provided during hearings. Therefore, DC, Surat stated that they are not inclined to renew the LOA of M/s. C Tech Corporation beyond 04.05.2025.

The Board, after deliberations and considering the facts of the case, agreed with the view of the Development Commissioner, Surat SEZ, and directed to ensure compliance of the conditions stipulated under Section 16(3) of the SEZ Act, 2005.
