Clarification to DC VSEZ reg pending TED refund for supply of duty paid HSD/Furnace Oil by Oil PSUs to EOU for manufacturing of granite articles

Please refer to the trailing email from M/s Midwest Group Companies regarding non release of Terminal Excise Duty claims by VSEZ.

This issue was also raised in the open house held by the then Commerce Secretary at Hyderabad on 30.8.2024. However, the issue has still remained unresolved. This issue is related to VSEZ only and not in other zones.

The issue is regarding reimbursement of TED claims to EOUs under Para 7.02(b) of FTP for supply of duty paid HSD/Furnace Oil from the depots of domestic oil PSUs.

DC VSEZ has requested clarification from DoC. DoC sought comments from DGEP. DGEP has clarified that the matter is related to Deemed Export Benefits under para 7.02(b) and hence DoC has to decide.

It is requested that a clarification may kindly be sent urgently to DC VSEZ that TED is eligible for supply of duty paid HSD/Furnace Oil for manufacturing of articles of granite for which LOP was given to EOU.
