Dear Sir

This is regarding the problem being faced when clearing goods from FTWZs to Customs Bonded Warehouses(CBW) which were inwards earlier in the FTWZ through SEZ Online/NSDL.

According to them, with introduction of the ICEGATE module, a significant issue has arisen:

- The new **ICEGATE** system does not recognize or map the legacy stock that was inwards into FTWZ/CBW through NSDL.
- As a result, **Customs authorities at CBWs are not permitting the clearance of such goods into DTA**, insisting that the transfers should have been routed through ICEGATE.
- Additionally, reference is being made to a **Trade Notice issued by JNPA SEZ Customs (copy enclosed)**, which further restricts the movement and clearance of such goods.

This has led to a situation where **legitimate cargo is stranded at CBWs**, with no procedural pathway available for clearance, causing operational and financial hardship to trade stakeholders.

It is requested to allow one time / time bound clearance procedures from FTWZ to Customs Bonded Warehouses for the legacy goods inwards into FTWZ through SEZ online upto a particular date.
